Goals of the FLA

Benefit the Free Software project and community:

- easier licensing maintenance
- can protect the projects/code
- can protect **the contributors**
- code will carry on
- project stays Free Software

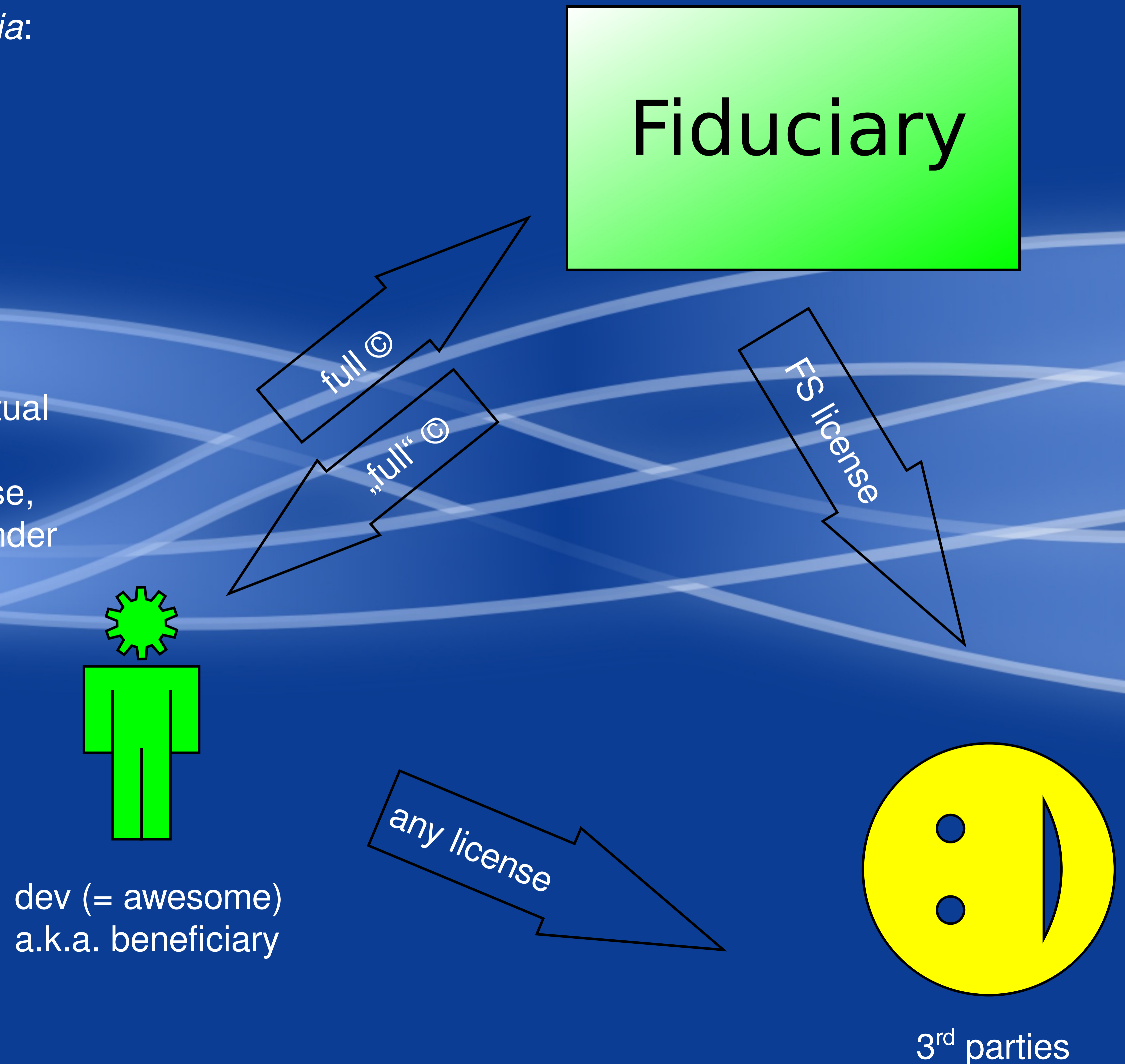
How does FLA work?

Beneficiary \Rightarrow Fiduciary:

- full © / exclusive, global license to *inter alia*:
- reproduce
- redistribute
- make available
- authorise 3rd parties to make derivatives
- original or modified work
- (excluding moral rights)

Fiduciary \Rightarrow Beneficiary (on own work):

- non-exclusive, global, unrestricted, perpetual version of above
- + non-exclusive, transferable license to use, reproduce, redistribute, make available under any license



Checks & balances

- ✓ Beneficiary basically still has all rights
- ✓ Fiduciary gains **responsible** power
- ✓ FLA is a versioned text (you agree to the version you signed)
- ✓ breach of trust \Rightarrow all rights back

1998: (L)GPLv2 \Rightarrow 2008: FLA* + FRP

Case: SELF Project

EU-funded educational project on Free Software and Open Standards

FLA 1.2 \Rightarrow FSFE

(project ended in 2009
FSFE is member of the consortium)

What we learnt

- project's life made easier
- it is well accepted by beneficiaries, but needs some further explanation
- administrative overhead (d'uh)
- FRP and patch policy = awesome idea

Future (1.x, 2.0, ...?)

- user friendlier
- even clearer wording
- more jurisdictions (e.g. Asia)
- (A)GPLv3
- patents
- trademarks
- ...whatever the community needs

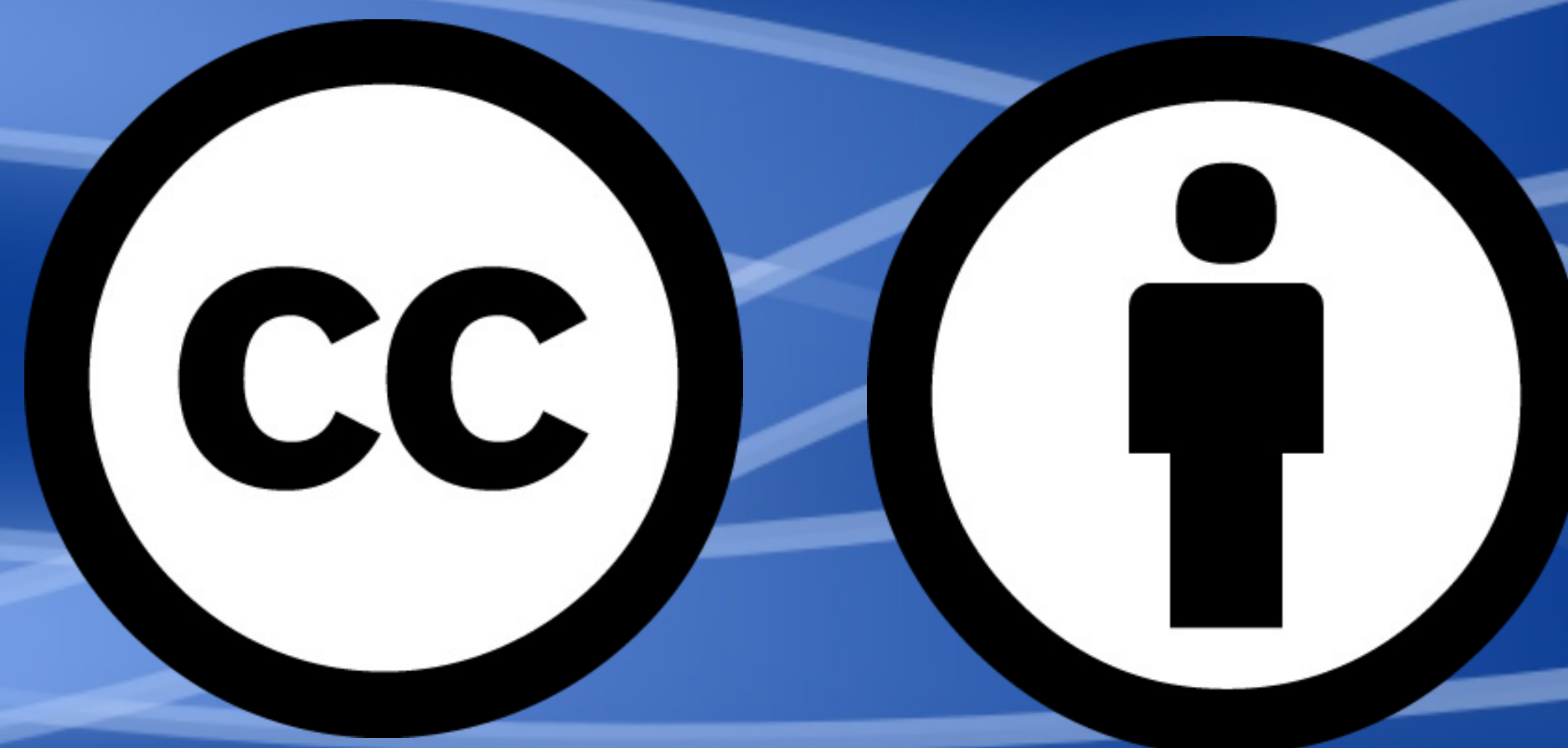
